# RECRUITING PROCESS CONTACT, EVALUATION, & VISIT

# **PROSPECTIVE STUDENT-ATHLETE**

An individual becomes a Prospective Student-Athlete (PSA) when they:

- Start classes in 9<sup>th</sup> Grade; or
- A college/university provides the individual (or their family/friends) with financial assistance or other benefits not provided to regular prospective students.

The student becomes a 'recruit' when a college institution:

- Provides the PSA with an <u>official</u> visit;
- Has arranged, in-person, off-campus <u>contact</u> with the PSA/family; or
- Issues a National Letter of Intent (NLI) or athletically-related financial aid agreement (FAA) to the PSA

# **CONTACTS AND EVALUATIONS**

#### Contact

- Face-to-face encounter between PSA/family and institutional staff member or athletics rep with dialogue in excess of greetings
- If the encounter is
  - Prearranged or happens at the PSA's school/practice site/competition site, it counts, regardless of whether there was conversation
- Permissible starting July 1 following 11<sup>th</sup> Grade (Exceptions apply)

#### **Evaluation**

 Off-campus activity designed to assess a PSA's academic qualifications or athletics ability, including visits to PSA's school (w/o contact) or observation of PSA participating in practice/competition

# **RECRUITING VISITS**

### **Unofficial Visit**

- PSA pays for their own trip (travel, lodging, food, etc)
- Permissible starting September 1 of 11<sup>th</sup> Grade (FB, BB exceptions)

### Official Visit

- Institution finances the entire visit (travel, lodging, food, etc.)
- Permissible starting September 1 of 11<sup>th</sup> Grade (FB, BB exceptions)
- Limit of 5 official visits, max of 1/school
- 48-hour time limit

# NCAA EC REGISTRATION

Register at www.eligibilitycenter.org

#### Required for

- Official visit approval
- Signing NLI
- Academic and Amateurism Certification

#### Fees

- Domestic: \$90 (US territories and Canada)
- International: \$150
- Waiver option for registration fee (see fee chart)

## NCAA DOCUMENT SUBMISSION ALL STUDENTS

## **ALL STUDENTS**

- Submit official transcripts from <u>all</u> schools attended
  - Electronically or via standard mail
  - HS Counselors upload transcripts via the high school portal (search NCAA High School Portal)
- Submit all ACT and SAT test scores
  - Code: 9999
  - Sum-Scoring system vs. Super-Scoring system

## NCAA DOCUMENT SUBMISSION INTERNATIONAL STUDENTS

### **Required Documents**

- Academic records for years nine and up, in native language <u>and</u> translated to English
- Proof of graduation, including certificates, diplomas or exit exams
- SAT or ACT scores

### Recommendation

- Send academic records directly to Compliance
- UCF can evaluate then send to NCAA EC

# NCAA ACADEMIC ELIGIBILITY INITIAL

## NCAA INITIAL ELIGIBILITY

## REQUIREMENTS

- Graduate from high school
- Complete 16 core courses
  - 10 units 'locked in' after junior year
  - 7 of 10 must be English/Math/Science
- Earn a minimum core course GPA of **2.300**
- Earn SAT or ACT sum score that corresponds
- with core GPA on sliding scale

## **INITIAL ELIGIBILITY**

## 16 CORE COURSES (approved core course list)

- 4 units of English
- 3 units of Math
- 2 units of Natural/Physical Science
- 2 units of Social Science
- 1 additional unit of English, Math or Science
- 4 units of additional core from any category above or foreign language

# **INITIAL ELIGIBILITY EVALS (IEE)**

## **Incoming Freshmen Only**

- Required prior to signing NLI/FAA
- Done in order to ensure that the PSA will be eligible to compete upon arrival
- Institutions will request 6-semester transcripts from the PSA and/or HS for the evaluation

- Required prior to signing NLI/FAA

# **NCAA ELIGIBILITY** AMATEURISM

## **AMATEURISM CERTIFICATION**

### **Mid-year Enrollees**

- Complete initial questionnaire during registration sport participation history, etc.
- Able to request final amateurism certification starting October 1 prior to enrollment in January

### **Fall Enrollees**

- Complete initial questionnaire during registration sport participation history, etc.
- Able to request final amateurism certification starting April 1 prior to enrollment in August

# COMMITMENTS & SCHOLARSHIPS TYPES & DIFFERENCES

## COMMITMENTS

### **Verbal Commitments**

- Anyone can verbally commit at any time. NON-BINDING
- Either side can back out at any time with no penalties
- Recruiting restrictions still apply

## **Real Commitments**

- Signing a NLI to attend an institution (FAA exception)
- A NLI is a legal, binding contract with penalties

## WHY VERBALLY COMMIT?

### **Common Reasons**

- "Lock in" a spot in the recruiting class (deadlines)
- Inform other schools you're no longer interested
- Focus less on recruiting, more on finishing school
- Social media = attention

## NLI AND FAA

## NLI

Binding agreement between PSA and institution

- PSA commits to attending that school for at least 1 AY
- School commits to funding all/part of the PSA's costs
- Other schools must stop contacting PSA, and PSA may not contact other schools

### FAA

- Only binds institution to PSA
- PSA is free to continue recruiting process

## **COLLEGE ADMISSIONS**

## Decisions

- Qualifier ≠ guaranteed admission—especially to semester of one's choice
- Consider type of deadline along with athletic recruitment process
- Consider institution averages and midranges

## **ADMISSIONS REQUIREMENTS**

### Points to Consider

- Requirements vary based on institutions
- Requirements may change from year to year
- Be mindful of different application rules and guidelines

## **ADMISSIONS REQUIREMENTS**

- PSAs will need to adhere to all university requirements including, but not limited to:
  - Submitting an official final transcript showing proof of graduation
  - Submitting official AICE/AP/CLEP/IB score reports directly from College Board/IB/Cambridge

## **APPLICATION PROCESS**

- Apply and pay application fee/submit fee waiver
- Submit the following documents:
  - Official high school transcripts or SSAR if applicable
  - Official SAT and ACT scores
- Upon graduation, submit official transcript with proof of graduation and final AICE/AP/IB/CLEP scores
  - Potential holds on account will delay financial aid disbursement and future course registrations

# FRESHMEN/FTIC (INTERNATIONAL)

## Process

- Transcripts
  - English and native language (sealed, stamped)
  - Submit final transcript/certificate/diploma showing proof of graduation
- SAT and/or ACT
- TOEFL/IELTS... unless one of the following
  - ACT English is  $\geq 20$
  - rSAT EBRW is  $\geq$  520
  - Complete 4 years of English in USA in American HS

## **ADMISSIONS DECISIONS**

Term of Admission is dependent upon Sport needs as well as strength of student's academic credentials.

University Admissions Office is responsible for rendering admissions decisions.

## **INTERNATIONAL VISAS (F-1)** Additional Required Immigration Docs

### **From Abroad**

- I-20 Request Form
- Copy of Passport with expiration page
- Certification of Finances Form
- Supporting Financial Documents (including Athletics Award and –if applicable-bank statement/bank letter to show proof of required funding for F-1 students)

#### **Transfer from US Institution** (already studying in the US as F-1)

- All forms listed above, <u>AND</u>
- Transfer Clearance Form (must be completed by an International Advisor at current institution)
- Copies of current F-1 visa, I-94 arrival record, and copies of all previous I-20s

- Submission of Immunization Records
- Orientation
- Schedule Planning
