Breakout 1a: *What Risks Should We Be Talking About?*

Risk management is an intentional approach to identifying, evaluating, and planning for risks that will likely affect your school. Finances, operations, and even your mission is at stake. Risks confronting independent schools are changing rapidly and continue to grow in complexity. How can school leadership decide which risks require attention, and who should focus on them? Informed by survey responses from nearly 250 independent school administrators about reputation and other risks that "keep you up at night," this session will identify those risks that the prudent business officer should plan for in the current environment.
